TOPIC**Visitation****POLICY****General Visitation**

The resident has the right to receive visitors of their choosing and at the time of their choosing in a manner that does not impose on the rights of another resident.

PROCEDURE

1. The Facility Manager is responsible for implementing this policy including but not limited to:
 - a. Policy and procedure updates as needed,
 - b. Staff, resident, and visitor education,
 - c. Staff adherence to policy and procedure, and
 - d. Monitoring and enforcement of visitation.
2. Visiting hours are:
 - a. Residents may have visitors any time, 24 hours a day, 7 days a week for as long as the resident wants and as many visitors as the resident wants if that does not impose on the rights of another resident.
 - b. Overnight visitation is subject to review and approval of the Facility Manager.
3. Visitors will not be required to show proof of vaccination or immunization status.
4. Residents may choose to have consensual physical contact with visitors.
5. Visitors will be provided general guidance and education for infection control policies and practices including but not limited to:
 - a. Infection control signage located throughout the facility,
 - b. Visitation policy will be posted on the facility website.
 - c. Guidance and education regarding utilization of PPE and hand hygiene will be provided by staff when visiting residents with signs or symptoms of respiratory illness or infectious disease resident,
 - d. Facility staff will screen essential caregivers or visitors, provide guidance and education regarding infection control practices, utilization of personal protective equipment (PPE), remaining in the resident's room and/or minimal movement throughout the facility and any other protocols recommended by Florida Department of Health or Agency for Health Care Administration at the time of visitation when visiting residents with signs or symptoms of respiratory illness or infectious disease.
6. The facility shall provide reasonable access to a resident by any entity or individual that provides health, social, legal, or other services to the resident, subject to the resident's right to deny or withdraw consent at any time. Facility shall provide space and privacy for such visits.

7. Reasonable clinical and safety visitation restrictions include, but are not limited to:
 - a. Keeping the facility locked or secured with a system in place for allowing visitors approved by the resident,
 - b. Denying access or providing limited and supervised access to an individual if that individual is suspected of abusing, exploiting, or coercing a resident until an investigation into the allegation has been completed or has been found to be abusing, exploiting, or coercing a resident,
 - c. Denying access to individuals who have been found to have been committing criminal acts such as theft,
 - d. Denying access to individuals who are inebriated or disruptive.
8. All residents have the right to privacy in their communications. Privacy for visitation or meetings might be arranged by using a dining area between meals, a vacant chapel, office, or room; or an activities area when activities are not in progress. Arrangements for private space could be accomplished through cooperation between the facility's administration and resident or family groups so that private space is provided for those requesting it without infringement on the rights of other residents.
9. Staff members will observe the visitor or essential care giver for adherence to infection prevention protocols. Those that refuse to comply, will be asked to comply, or asked to exit the facility.

Governmental Visitation Restriction "No Patient Left Alone Act"

In the event of advised governmental visitation restriction the resident may designate a visitor who is a family member, friend, guardian, or other individual as an essential caregiver to provide in-person visitation. The facility will add the essential care giver to the residents contact list.

Designated Essential Caregiver

As mentioned earlier in the policy, the essential caregiver or visitor will be screened, educated regarding infection control practices, personal protective equipment, remaining in the resident's room and/or minimal movement throughout the facility and any other protocols recommended by Florida Department of Health or Agency for Health Care Administration at the time of visitation when visiting residents with signs or symptoms of respiratory illness or infectious disease.

The essential caregiver or visitor may stay for a maximum of 2 hours daily in addition to any other visitation guidelines and may have consensual physical contact with the resident.

The essential caregiver is not required to provide necessary care to the resident. The facility must allow visitation under the following circumstances:

- End-of-life situations.
- A resident who was living with family before being admitted to the provider's care is struggling with the change in environment and lack of in-person family support.
- The resident is making one or more major medical decisions.
- A resident is experiencing emotional distress or grieving the loss of a friend or family member who recently died.
- A resident needs cueing or encouragement to eat or drink which was previously provided by a family member or caregiver.
- A resident or patient who used to talk and interact with others is seldom speaking.

In person visitation may be suspended if the visitor violates the policies and procedures.
